

**KING AND QUEEN COUNTY TAXES DUE DECEMBER 5, 2023  
PERSONAL PROPERTY TAXES**

**PUBLIC TAX NOTICE:**

**Personal Property Tax Relief Notice**

In accordance with changes by the 2005 General Assembly, delinquent tax bills for years 2001-2005 that remain unpaid as of September 1, 2006 will require 100 percent of the original tax to be paid by the TAXPAYER.

**Tax Payments:**

This year you can pay your taxes several ways: (1) locked drop box which is located at entrance of building; (2) at one of the two banks listed below; (3) mail; (4) credit card over the phone; (5) credit card over the internet; (6) call the Treasurer's Office and pay with a credit card. **Avoid standing in line by using one of the above options!**

**LOCKED DROP BOX:** As you enter the building, at the entrance to the Sheriff's Office is a *locked drop box*. You have the ability to enter the building and use the drop box 24 hours a day - seven days a week to pay taxes!

**TO PAY TAXES AT THE BANK:**

Taxes may be paid for the exact amount printed on the enclosed bill at the bank. The following locations have agreed to collect taxes for King and Queen County for the 2023 year:

United - Manquin, Tappahannock, and West Point  
C & F - West Point (14th Street), Middlesex and Mechanicsville

No tax bill will be accepted after December 5, 2023 at any bank. You must present the bottom portion of your tax bill when paying at any bank. After December 5, 2023 taxes must be paid at the Treasurer's Office or mailed with a December 5, 2023 postmark.

**TO PAY TAXES BY MAIL:**

Mail your taxes by the due date in the enclosed envelope. So that taxes can be posted correctly to your account, you must mail the bottom stub from your tax bill for each account you wish to pay. The official U.S. postmark will be used as the posting date. Please send self-addressed stamped envelope if a receipt is desired.

**TO PAY TAXES BY CREDIT CARD OVER THE PHONE:** (Visa, MasterCard, American Express or Discover) Dial 1-800-272-9829 from any touch-tone phone. Information you will be asked to supply: (1) jurisdiction code for King and Queen County which is 6221; (2) personal ID number (social security number); (3) valid credit card number and (4) daytime telephone number. A handling charge will be added to each credit card payment.

**TO PAY TAXES BY CREDIT CARD OVER THE INTERNET:** (Visa, MasterCard, American Express or Discover): Go to website [www.officialpayments.com](http://www.officialpayments.com) to begin the process. Information you will be asked to supply: (1) jurisdiction code for King and Queen County which is 6221; (2) personal ID number (social security number); (3) valid credit card number and (4) daytime telephone number. A handling charge will be added to each credit card payment.

**COLLECTIONS:** Failure to pay this bill by the due date can cause a delay in state income refund, DMV registration renewals, invoke liens, garnishments or other collection procedures per the Code of Virginia.
