PUBLIC COMMENT PERIOD

PUBLIC HEARING/ONE TIME BONUS TO LAW ENFORCEMENT OFFICERS

Chairman Alsop advised that the Board will hold a public hearing on a proposed ordinance allowing for a one-time bonus for law enforcement officers. She asked the County Administrator for proof of publication and background information.

Mr. Swartzwelder advised that the hearing was properly advertised for two consecutive weeks in the Tidewater Review and the Rappahannock Times. He further advised that as part of the state budget, the Compensation Board approved a one time \$3,000 bonus for state funded law enforcement officers. The Sheriff has requested that law enforcement officers in locally funded positions who have been employed with the County for at least one year be included as well.

Chairman Alsop opened the hearing for comments from the public. Hearing no comments from the public, the hearing was closed.

QUARTERLY REPORTS

Quarterly Reports were provided by the following Constitutional Officers, Department Heads and Agencies:

- Sheriff Captain Balderson advised the Deputy Simmons is retiring at the end of October. The Sheriff provided a written report in advance and he was available for any questions. Ms. Morris asked if they had been able to hire any new deputies and also asked that if they had the staff, to please continue working on Rt. 614.
- Commonwealth Attorney Meredith Adkin provided the following:
 - o COVID restrictions have been put back in place due to resurgence, this is causing continuances in some cases.
 - o Recently processed 17 felony indictments, most related to illegal drug charges
 - The Sheriff and the courts have been doing a good job moving charges through the system

- She has been providing training to deputies on new law changes
- o Her paralegal has resigned and she is in the process of hiring a new one.
- Treasurer- Provided her report in advance.
- Commissioner of Revenue Kelly Lumpkin provided the following report:
 - Personal property and business property for 2021 have been reviewed and assessed.
 - o Real estate bills were submitted to the Treasurer's office on August 30th.
 - o Personal Property bills were submitted to the Treasurer's office on August 27th.
 - 56 applicants were qualified for Elderly and Disabled credits this year totaling \$16,040.84 and real estate credit for veterans is \$22,437.27 and personal property for veterans is \$14,878.56
 - o Vehicle values have increased due to COVID, she provided a letter explaining.
 - Taxes are due December 5th; her office is happy to assist anyone with questions.
 - o 2022 Business Licenses will be processed to the Treasurer's office by October 29th and are due by March 1st.
 - Vehicle licenses exemptions have been sent to volunteer fire and rescue agencies and are due back by January 31st.
- Clerk of Circuit Court Vanessa Porter provided her report in advance and was present to answer any questions.
- Director of Social Services Betty Dougherty provide an FY2021 CSA report to the Board in advance and provided an overview of the program.
- School Superintendent Dr. Carter provided a written report in advance but also had the following updates:
 - School began with in person instruction of August 24th
 - o The current ADM is 818 with 636 'brick and mortar' students
 - o The division has received a technology grant in the amount of \$104,000
 - o Division wide COVID protocols are in place. There have been 29 cases between staff and students.
 - Homecoming has been postponed due to a football player testing positive for COVID.
 - o October 29th will be Senior Night.
 - They have one elementary teacher vacancy and have been struggling getting substitutes.
 - o The volleyball team is doing well.
 - CHS received a 21st Century Grant in the amount of \$148,000 for after school programs and the division is using CARES Learning Loss funds to provide after school programs at the elementary schools.
- Republic Services Jeff Davison provided a written report in advance and also gave the following updates:
 - o O3 tonnage is about the same as O2.
 - o Host fee payments have been made and the contingency fund payments have been adjusted based on CPI.
 - o Annual donations to fire and rescue agencies will be delivered in December.
 - o Their most recent DEQ inspection went very well.
 - o He heard Ms. Morris' comments on truck traffic and will make a few calls to remind drivers.

- VDOT- Ron Peaks provided a written report in advance and went over the items contained in the report. Ms. Alsop questioned the repairs reported to have been made on Rt. 625, that it is still in very bad shape. He will look into the matter.
- Cooperative Extension A report was provided in advance.

MPNNCSB PRESENTATION AND APPROVAL OF ANNUAL PERFORMANCE CONTRACT

CSB Executive Director Linda Hodges updated the Board on services provided by the CSB as well as the financial and service delivery affects from COVID. She reviewed the annual performance contract and accepted questions and comments from the Board.

ADOPTION OF RESOLUTION PERTAINING TO THE SETTLEMENT WITH OPIOID DISTRIBUTORS

Mr. Swartzwelder advised that this resolution is the next step in the litigation process for the opioid lawsuit. A motion was made by Mr. Bailey and seconded by Ms. Morris to adopt the following resolution:

RESOLUTION

A RESOLUTION OF THE KING AND QUEEN COUNTY BOARD OF SUPERVISORS APPROVING OF THE COUNTY'S PARTICIPATION IN THE PROPOSED SETTLEMENT OF OPIOID-RELATED CLAIMS AGAINST MCKESSON, CARDINAL HEALTH, AMERISOURCEBERGEN, JANSSEN, AND THEIR RELATED CORPORATE ENTITIES, AND DIRECTING THE COUNTY ATTORNEY AND/OR THE COUNTY'S OUTSIDE COUNSEL TO EXECUTE THE DOCUMENTS NECESSARY TO EFFECTUATE THE COUNTY'S PARTICIPATION IN THE SETTLEMENTS

WHEREAS, the opioid epidemic that has cost thousands of human lives across the country also impacts King and Queen County by adversely impacting the delivery of emergency medical, law enforcement, criminal justice, mental health and substance abuse services, and other services by King and Queen County's various departments and agencies; and

WHEREAS, King and Queen County has been required and will continue to be required to allocate substantial taxpayer dollars, resources, staff energy and time to address the damage

the opioid epidemic has caused and continues to cause the citizens of King and Queen County; and

WHEREAS, King and Queen County has filed suit against McKesson, Cardinal Health, AmerisourceBergen, and Janssen Pharmaceuticals, along with certain of their related corporate entities for their role in the distribution, manufacture, and sale of the pharmaceutical opioid products that have fueled the opioid epidemic that has harmed King and Queen County; and

WHEREAS, The County's suit seeks recovery of the public funds previously expended and to be expended in the future to abate the consequences and harms of the opioid epidemic; and

WHEREAS, settlement proposals have been negotiated that will cause McKesson, Cardinal Health, AmerisourceBergen, and Janssen to pay up to \$26 billion nationwide to resolve opioid-related claims against them; and

WHEREAS, King and Queen County outside opioid litigation counsel has recommended that the County participate in the settlements in order to recover its share of the funds that the settlement would provide; and

WHEREAS, the County Attorney has reviewed the available information about the proposed settlements and concurs with the recommendation of outside counsel;

NOW THEREFORE BE IT RESOLVED that the King and Queen County Board of Supervisors, this 12th day of October, 2021, approves of the County's participation in the proposed settlement of opioid-related claims against McKesson, Cardinal Health, AmerisourceBergen, Janssen, and their related corporate entities, and directs the County Attorney and/or the County's outside counsel to execute the documents necessary to effectuate the County's participation in the settlements, including the required release of claims against settling entities.

POSSIBLE EXTENSION OF THE FILING DEADLINE FOR 2021 ELDERLY AND DISABLED TAX CREDIT EXEMPTION

Mr. Swartzwelder advised that this item was brought forth by a board member. Mr. Simpkins stated that he had been notified by a citizen that they submitted their paperwork prior to the deadline but it was never received by the Commissioner's office. The citizen did not realize this until they received their tax bill without the reduction. He asked that the board do something due to the circumstances at the time relating to COVID and mail service delays.

Mr. Swartzwelder provided the following emergency ordinance that would be allowable due to the circumstances:

Emergency Ordinance pursuant to 15.2-1427 (F)

Due to issues created by the Covid 19 pandemic along with significant delays and other problems with the US Mail, the deadline for filing the application for the Elderly/Disabled Tax Credit Exemption of April 1, 2020, as set forth in Chapter 30, Article II, Sec.30-46 of the County Code is hereby extended until Friday November, 3 2021.

This Emergency Ordinance is not enforceable for more than 60 days following adoption.

COUNTY ADMINISTRATOR'S COMMENTS

➤ The federal funding for the fiber project has been released so the project can continue to move forward.
