A. CBPA14-01, Chesapeake Bay Exception – Kerry and Betsy Basehore – Set Public **Hearing Date** 

Mr. Richardson advised that Kerry and Betsy Baseshore are requesting a Chesapeake Bay Preservation Area Exception for the proposed construction of a 12' x 30' residential addition, consisting of an additional hardening of 160.85 sq. ft., in the landward 50' RPA. The subject property is located at 1322 Tuckers Road, Tax Map #1623-131L-394A in the Buena Vista Magisterial District.

Zoning Administrator Mr. Swartzwelder provided a brief overview of the above request.

Kerry Basehore was present to answer any questions of concern that the Planning Commission may have and advised that the proposed addition would be a 12' x 30' addition to the back of his home in which to enlarge the kitchen, dining area and new bathroom. Mr. Basehore further commented that he plans to replace the existing deck and put on the front and move the back entrance to the side. Mr. Basehore thanked the Commission members for their consideration of his request.

A motion was made by Mr. Coleman and seconded by Mr. Watkins to advertise for a Public Hearing on CPBA14-01, Chesapeake Bay Preservation Area Exception as requested by Kerry and Betsy Basehore.
