# B. Interpretation of Article 4, Table 4.1 – Livestock & Acreage requirements

Mrs. Sprouse briefly explained that the current and proposed revised zoning ordinance (Article 4, Table 4.1) does not specifically address miniature horses, miniature goats, and pot belly pigs. She stated that it has become a recent trend that several localities have recently faced and asked if the Commission had any comments about adding such to the ordinance with different requirements other than larger livestock animals. Mr. Herrin made a motion to table the discussion until they had more information. Mrs. Sprouse asked Mr. Herrin what additional information he wanted. Mr. Herrin noted that he would like to have the definition of such animals and how other localities handle such. Mr. Herrin's motion was seconded by Mr. Guess.
