Budget Amendment - Clerk of Circuit Court

ACTION REQUESTED:

- 1. The Virginia Compensation Board has approved a third staff position in the office of the Clerk of Circuit Court for FY2022. The Clerk is requesting a budget amendment to cover the cost of this position. The state is funding approximately \$34,352 and an additional local share of \$17,683 would be required in order for the position to be filled.
- 2. The newly funded position is considered an entry level clerk position. This places the salary at the same level as the current clerk in this office. The Clerk of Circuit Court is requesting a salary adjustment for this employee in the amount of \$3,807 to bring her salary to \$36,000. The total cost of this adjustment including benefits would be \$4,477 and is 100% local since this is above the Compensation Board approved salary.

Federal Funding Policy/Conflict of Interest Policy New audit requirements in place require the County to have in place policies to set guidelines for Finance staff to follow for use of federal grant funds. The policies comply with federal regulations set forth by the Federal Office of Management and Budget.
- 2. Update of Requisition/Purchasing Policy and Small Purchase Resolution The General Assembly has updated provisions within the Virginia Public Procurement Act (VPPA) several times since the County adopted is small purchasing policy. By updating the Small Purchase Resolution to the new limits as set forth in the VPPA it changes the policy as to the process required for purchasing and procurement methods.
