- 1. Regular meeting of K&Q County EB was held on Tuesday, October 11, 2022. Meeting was called to order at 9:02 a.m. by Chairman, J. Armistead Ransone.**
- 2. Minutes of previous meeting were reviewed, & approved as corrected.**
- 3. GR presented EB more updated IT Security Assessment Policies for review & signatures.**
- 4. GR updated EB re: K&Q County Proposed Precinct Relocations:
Proposed changes to Precincts 301, 401, 501, & CAP will be presented to the K&Q BoS Monday, October 24, 2022:
***GR restated: Any Precinct change will be effective January 1, 2023.**
- 5. GR updated EB re: status Early Absentee Voting:
90 ballots on scanner;
approximately 200 AB ballots have been requested & mailed to K&Q voters: of those, 57 completed ballots have been received via mail to GR.**
- 6. GR reviewed plans re: General Election, Tuesday, November 8, 2022:**
 - *DMV (aka "Motor Voter") registration backlog affected ~80 K&Q voter registrations: these registrations have been completed.**
 - *GR reminded EB going forward, this situation should no longer occur, with "Same Day Voter Registration".**
 - *Emergency Precincts will be confirmed by EB.**
 - *EB reviewed list of Election Day OE for each precinct.**
 - *OE Training is scheduled Tuesday, October 25, 2022.**
 - *Friday, October 28, 2022: Last Day to apply for Mail AB: GR Office to remain Open until 5:00 p.m.**
 - *K&Q County Saturday In-Person AB Voting: Saturday, October 29, 2022, & Saturday, November 5, 2022: 8:30 a.m.—4:30 p.m.**
 - *Election Preprocessing will occur Tuesday, November 1, 2022, & Friday, November 4, 2022. A representative from each party, as well as GR, will participate. EB participation is welcomed, but not mandatory.**
 - *Election night precinct-specific equipment pick-up was reviewed.**
 - *EB reviewed Election Day preliminary Checklists. Each EB member**

will receive 5 Checklists prior to Election Day.

***GR reviewed proposed plans for changes to local party tent placement re: 201 construction.**

****GR restated: Mandatory 40 foot restriction of campaigning activities for all parties.**
