A request has been received from the Emergency Service Coordinator to allow him to order the next ambulance as proposed in the replacement schedule because the vendor has notified him that the most recent delivery date estimates are 33 months. If the one that is on order now arrives when it is scheduled to, ordering the next one now will prevent the replacement schedule from getting even further behind.

KQES PROJECT UPDATE

Architect, Richard Corner, provided an update on the status of the project. This included the recent discussions of the committee regarding the possible location of the temporary classrooms at the high school rather than at KQES, the possible change away from the replace/renovate proposal to full replacement and the changes in cost estimates due to the economy for both. Mr. Burns and Mr. Swartzwelder also provided updates on the discussions that the project committee is having and the need to spend more time looking at the overall project before proceeding.

Ms. Seay also advised that the funding provided by the original Skanska contract have been exhausted and in order to keep them working on the projects a contact amendment is needed. She added that they assistance with all of the county capital projects has been invaluable.
