#### Parcel 24-35L-603E

Mr. Gibson stated that mobile home was way too high for a 1988 model, which was assessed at \$35,500. They had no problem with land value. Home is on permanent foundation and went from personal property to real estate. Board decided to change the depreciation

#### Parcel 23-158L-758

Questioned the price increase of the land, but the board decided not to change.

### Parcel 23-159R-748

Board said the only thing they could do for this property is to change the timber value, but did not want to do that because the value would go up.

Board decided not to change.

#### Parcel 24-34L-353

Board looked at the assessment value going up by \$38,100 and decided that it was in line with other properties.

Board decided not to change.

#### Parcel 24-52R-974A

Increased from \$161,300 to \$156,100, same as other properties that went up so Board decided <u>not to change</u>.

Parcel 24-52R-974

Property was adjoined with 974A, but they are both deeded separately. Change acreage from 23.75 to 16 acres
Timber from 40.0 to 47.75
Board <u>agreed to change</u>.

#### 24-51R-412B

Timber M 30 acres under 10 years reseeded.

Board decided to change from M to N classification @\$200.00 acre.

#### 24-51L-439

Board <u>decided to change</u> the timber from J to N classification @ \$200 from \$500 per acre.

## 24-53L-72A

Concerned by the fact that they had just bought land and it went up by \$38,000 more than what they purchased it for.

Board felt that it was in line with other properties decided not to change.

#### 24-32L-1041

Board felt that it was in line with other properties decided not to change.

### 24-52L-500

Board felt that it was in line with other properties decided not to change.

## 24-50L-376-1 through 24-50L-376-8

All properties all considered continuous that equal 44.25 acres, considered as one parcel.
