PROVISIONAL BALLOT MEETING:

1) On Monday, March 11, 2024 @12:58 p.m., Electoral Board of K&Q County met in the King & Queen County Circuit Court Room, to review results reported on election night, Tuesday, March 5, 2024.

In Attendance: Stuart Swilley, Linda Culbreth, Martha E. Hart, GR Diane Klausen, & K&Q County Republican Party Chair, William "Bill" Rilee.

2a) K&Q County EB Chair, Stuart Swilley, made a motion to convene the EB of K&Q County in closed session, pursuant to Section 24.2-653 (B) of the Code of Virginia for the purpose of considering whether each person who submitted a provisional vote at the March 5, 2024 Presidential Primary Election was qualified to do so.

2b) K&Q County EB Chair, Stuart Swilley, also made a motion that the GR & any authorized representatives of the candidates or political parties as specified in Section 24.2-653 (B), be allowed to remain in the room during the closed meeting, & that any persons who cast provisional votes & who are present, be allowed to enter the room while their qualifications are considered, to present any relevant information on their behalf to the Electoral Board.

2c) Both motions were seconded by K&Q County EB Vice Chair, Linda Culbreth.

2d) Both motions carried by unanimous vote of K&Q County EB.

3a) After review of voter qualifications in closed session, K&Q County EB Chair, Stuart Swilley, announced the closed session provisional ballot meeting will now reconvene as an open meeting.

K&Q County EB Chair, Stuart Swilley made a motion that the EB of K&Q County certify that in closed session just concluded, the only matters discussed were the qualifications of provisional voters, as directed by Section 24.2-653 of the Code of Virginia, & as identified in the motion, to close the meeting pursuant to the Virginia Freedom of Information Act (FOIA).
