- 3. A sign at the entrance of the project displaying the last name of the property owner must be posted prior to application submittal.
- 4. The outside limits of the proposed clearing or grading area must be clearly flagged on site prior to application submittal. Flagging should be labeled with what it represents. There should be flags a minimum of every 50 feet. The 100 foot buffer of all jurisdictional wetlands within 200 feet of the land disturbance must also be flagged.
- 5. An Erosion and Sediment Control Permit is issued on the basis of the approved plans and application and authorizes only limits of clearing and grading and/or other land disturbance set forth in the approved plans and application. Any deviations from the plans and application submitted shall render the Erosion and Sediment Control Permit null and void and constitute a violation of Chapter 5 (Erosion and Sediment Control Ordinance) of the King and Queen County Unified Land Use Regulations.
