**Sec. 30-132. - Vehicles exempt from payment.**

In addition to any other exemptions/discounts provided by law, the following vehicles shall be exempt from payment of the county vehicle license fee.

(a) Notwithstanding any other provision of this section to the contrary, there will be no annual vehicle license fee on one motor vehicle, motorcycle, or vehicle of like design owned by any member of a King and Queen County Volunteer Rescue Squad or member of a King and Queen County Volunteer Fire Department used regularly to respond to calls, provided, that such member of a King and Queen County Volunteer Rescue Squad or King and Queen County Volunteer Fire Department shall furnish the commissioner of the revenue, or other assessing officer, at a time established by the commissioner of the revenue, with a certification by the chief or head of the volunteer organization, that such volunteer is a member of a King and Queen County Volunteer Rescue Squad or King and Queen County Volunteer Fire Department who regularly responds to calls and the motor vehicle, motorcycle, or vehicle of like design is owned by such member.
