The Electoral Board of King & Queen County met @10:00 a.m. Wednesday, November 12, 2025 in the King & Queen County Circuit Court Room, 242 Allen's Circle, King & Queen Court House, VA.

### **In Attendance:**



1. **EB Chair, Stuart Swilley, announced, "The Electoral Board of King & Queen County, VA, will reconvene the Canvass for the Tuesday, November 4, 2025 Virginia Gubernatorial Election, for the purpose of adjudicating Same Day Registration (SDR) provisional votes."**
2. **Canvass of post-election results for the Tuesday, November 4, 2025 Virginia Gubernatorial Election was completed.**
3. **A motion was made by EB Chair, Stuart Swilley, & seconded by EB Vice Chair, Linda Culbreth, to conclude the Canvass of SDR Provisional Ballots cast during the Tuesday, November 4, 2025 Virginia Gubernatorial Election. The motion passed unanimously.**
