The Electoral Board (EB) of King & Queen County met Wednesday, November 12, 2025 in the Hearing Room of the K&Q County Circuit Courthouse. The EB meeting was called to order at 11:39 a.m. by Stuart Swilley, Chair. ****This EB meeting commenced immediately following Post-Election Canvass Day 2.**
In Attendance: EB Members Stuart Swilley, Linda Culbreth, Martha E. Hart, & GR Kristy Creech.
Minutes of the previous EB meeting Tuesday, October 14, 2025 were read, reviewed, & unanimously approved after date clarification re: VEBA Training.

Unfinished Business:

GR & EB reviewed calendar of pertinent events:

1. Post-November 2025 Election, per procedure, a random drawing for participation in the Statewide Risk-Limiting Audit (RLA) of the House of Delegates Election, will occur Monday, November 17, 2025. Localities randomly chosen to participate in the RLA will be notified the week of November 18—20, 2025. The RLA will be completed by Friday, November 21, 2025.
2. VEBA (Virginia Electoral Board Association) 51st Annual Conference will be held Monday, March 23—Wednesday, March 25, 2026 at The Omni Homestead Resort & Spa, Hot Springs, VA.
3. 2026 VEBA "Boot Camp Training": (Specific Dates & Times TBA)
Sunday, February 1, 2026 in Milford, VA, & Monday, March 23, 2026 during VEBA 51st Annual Conference: The Omni Homestead Resort & Spa, Hot Springs, VA.
*Registration: Monday, December 15, 2025—Saturday, January 31, 2026 via link to be established on the VEBA website.
***GR reminded EB: "Pursuant to 824.2-106 D of the Code of Virginia, each member of the EB shall attend an annual training program provided by the State Board during the first year of appointment, & the first year of any subsequent reappointment."

New Business:

1. GR informed EB: participants for the Post-November 2025 Election RLA of the VA House of Delegates Election randomly chosen per procedure described above, will be notified Monday, November 17, 2025.
(GR will subsequently notify EB, should K&Q County be chosen for the RLA.)
**The Statewide RLA will take Friday, November 21, 2025.
2. GR informed EB Total Voter Turnout for Tuesday, November 4, 2025 VA Gubernatorial Election was approximately 60%.
3. GR complimented EB for "adhering to non-political and non-religious decorum in the performance of EB duties during the Tuesday, November 4, 2025 VA Gubernatorial Election".
4. GR & K&Q Public Schools are in early discussion re: potential development of Public Service Announcements (PSAs) to include information re: Voter Rights & Responsibilities.
