
- 2a) **EB Chair, Stuart Swilley, announced, "The Electoral Board of King & Queen County, VA, will open the Provisional Ballot Meeting for the Tuesday, November 4, 2025 Virginia Gubernatorial Election." Provisional ballots were reviewed and processed according to standards set by the Virginia Department of Elections/ELECT.**
- 2b) **Stuart Swilley, EB Chair announced: "There being only Same Day Registration (SDR) provisional ballots left, I move that the Provisional Ballot meeting of the Electoral Board of King & Queen County, VA, adjourn until Wednesday, November 12, 2025 @10:00 a.m. in the King & Queen County Circuit Court Room, 242 Allen's Circle, King & Queen Court House, VA, at which time, the Electoral Board will consider whether each person who submitted a provisional ballot during the election was qualified to do so."**
- 2c) **Motion was seconded by EB Vice Chair, Linda Culbreth, to adjourn the Provisional Ballots meeting.**

1. **At 10:12 a.m., EB Chair, Stuart Swilley, announced, "The Electoral Board of King & Queen County, VA, will now begin the Canvass of results for the Tuesday, November 4, 2025 Virginia Gubernatorial Election."**
- 2a) **EB Chair, Stuart Swilley, announced, "Results received on Election Day have been reviewed by the Electoral Board. All precinct results were called in, reported, and recorded correctly. I move the King & Queen Electoral Board's Canvass of the Tuesday, November 4, 2025 Virginia Gubernatorial Election adjourn until Wednesday, November 12, 2025 @10:00 a.m. The meeting will be held in the King & Queen County Circuit Courtroom, located @242 Allen's Circle,**

King & Queen Court House, VA. The Electoral Board will conclude the Canvass after Post-Election Processing Review, & after the adjudication of Same Day Registration (SDR) Provisional Ballots is complete."
