The Electoral Board (EB) of King & Queen County met Tuesday, December 16, 2025 in the office of the General Registrar of K&Q County. The EB meeting was called to order at 9:22 a.m. by Linda Culbreth, vice chair.
In Attendance: EB Members Linda Culbreth & Martha E. Hart, & GR Kristy Creech.
Minutes of the previous EB meeting Wednesday, November 12, 2025 were read, reviewed, & unanimously approved.

Unfinished Business:

GR & EB reviewed calendar of pertinent events:

1. VEBA (Virginia Electoral Board Association) 51st Annual Conference will be held Monday, March 23—Wednesday, March 25, 2026 at The Omni Homestead Resort & Spa, Hot Springs, VA.
2. 2026 VEBA "Boot Camp Training":

***GR reminded EB: "Pursuant to §24.2-106 D of the Code of Virginia, each member of the EB shall attend an annual training program provided by the State Board during the first year of appointment, & the first year of any subsequent reappointment."
3. GR informed EB: On Friday, November 21, 2025, the Statewide Risk-Limiting Audit (RLA) of the Post-November 4, 2025 Election for the VA House of Delegates Election in District 92, in the words of VEBA, "proved what we already knew—our equipment and processes work as they should."

2. GR reiterated to EB the ongoing statewide concerns re: USPS & late-arriving mailed ballots.
3. GR informed EB: the November 4, 2025 Post-Election Survey has been completed.
4. GR & EB reviewed information re: Albemarle County's November Gubernatorial Election Day ESGSTM (Election Systems & Software) scanner failures.
5. GR informed EB of a potential Special Election in 2026 re: redistricting throughout the Commonwealth.
6. GR informed EB: FY2026—2027 Budget packet has arrived. GR & EB discussed preliminary budget plans.
